A. Financial Performance (2008-2011):

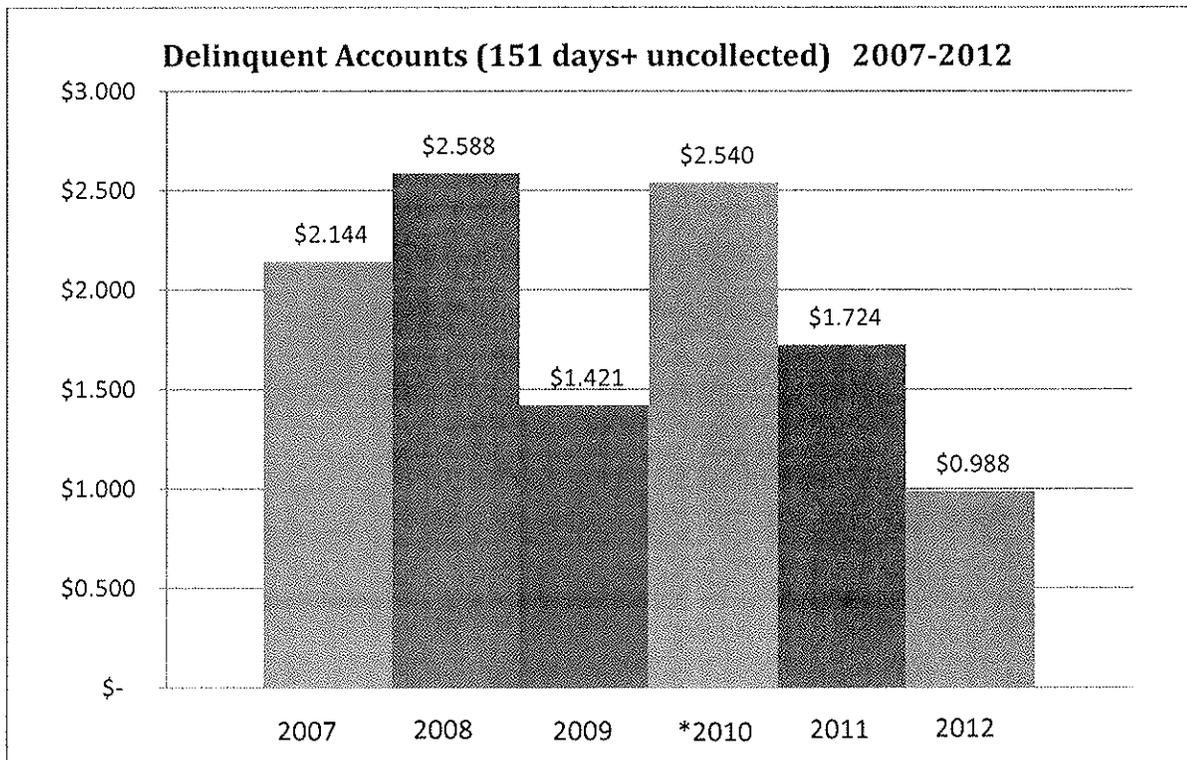
1. Change in Total Operating Revenue	+ \$5.75 million

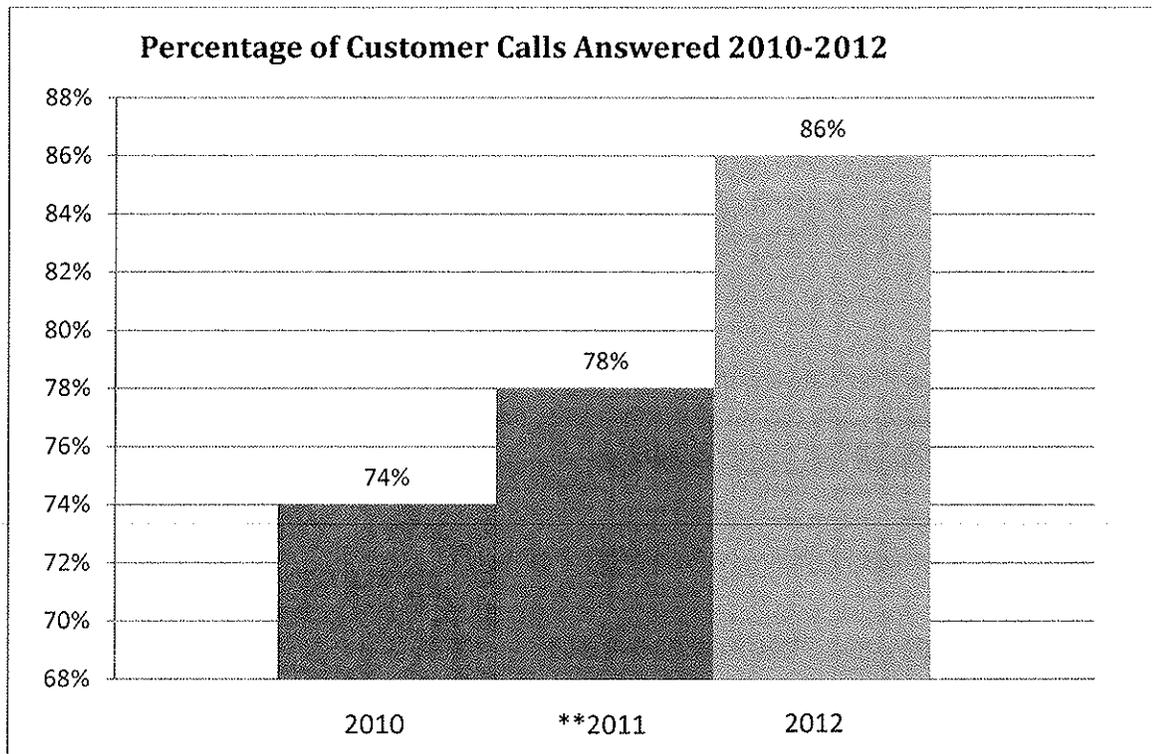

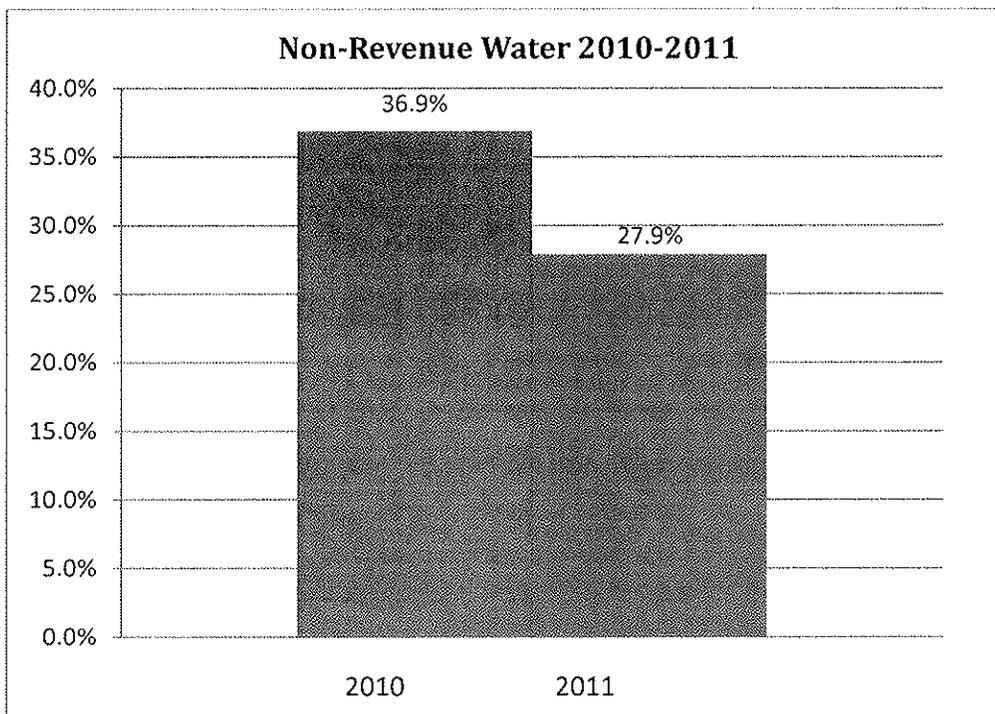

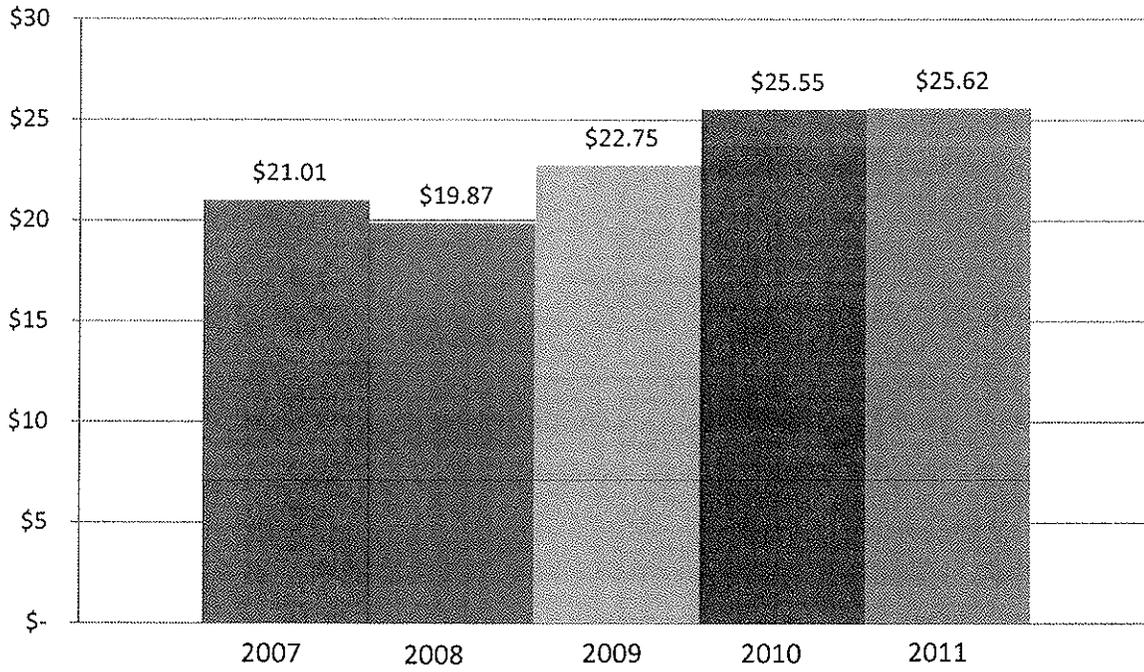

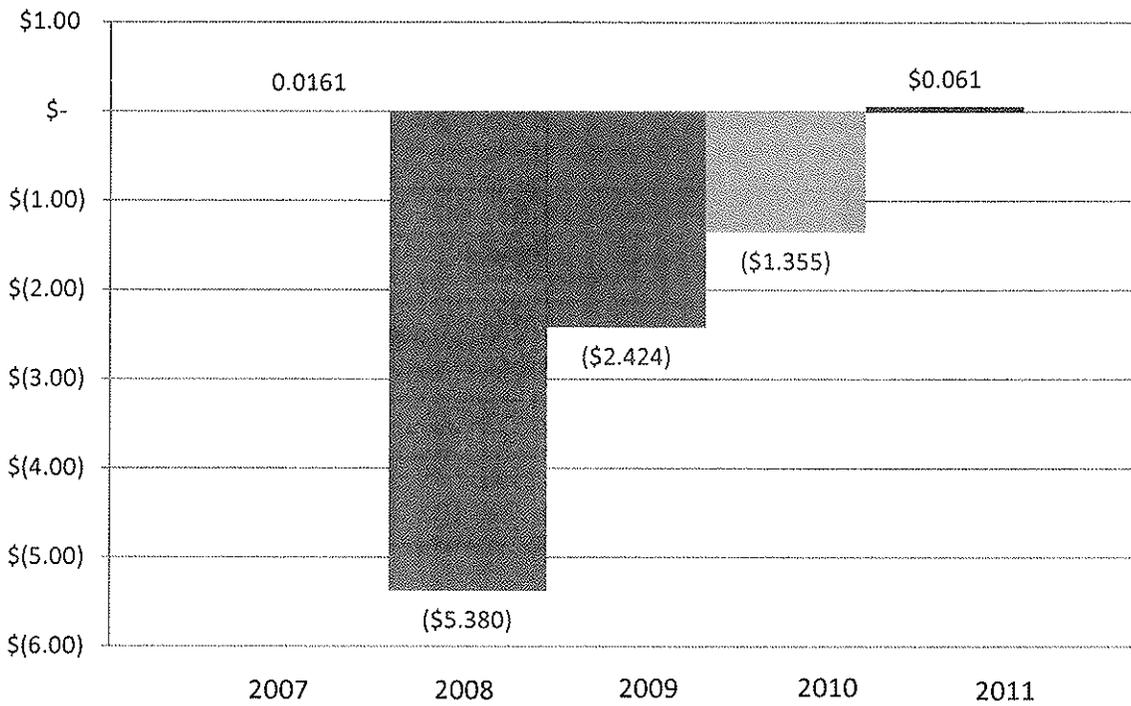

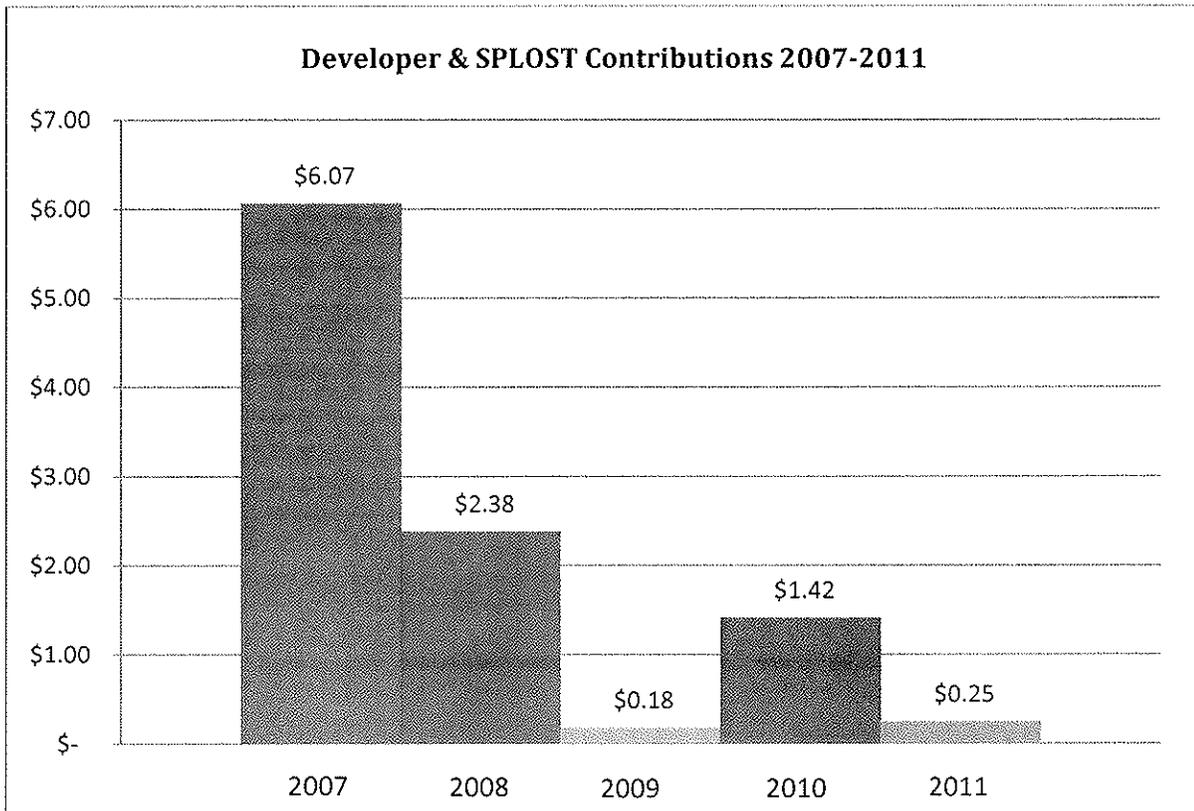
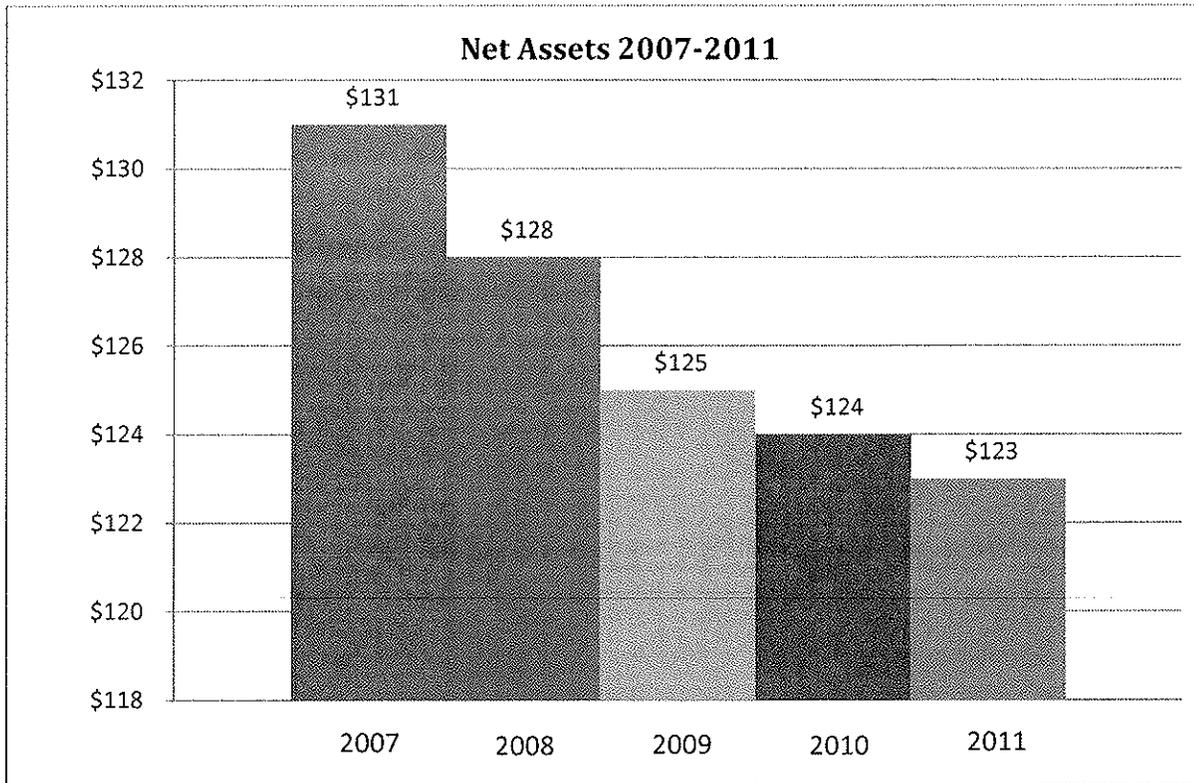
Total Operating Revenue (less CCR) 2007-2011
